COOPERATION AGREEMENT

Concluded between:

The UNIVERSITY OF NİS, FACULTY OF LAW, Nis, Trg kralja Aleksandra 11, PIB 101532192, represented by Dean prof. Dr. Goran Obradović, and

The UNIVERSITY of PARMA, Department of LAW, POLITICS AND INTERNATIONAL STUDIES, electing its legal address in 43121 Parma, via Università 12, represented by its Rector, Prof. Dr. Paolo Andrei and, for the Department, by the Director Prof. Dr. Giovanni Francesco Basini.

Article 1.

The Faculty of Law in Nis (hereinafter: the Faculty) and the Department of Law, Politics and International Studies of the University of Parma (hereinafter: the Department), by signing this agreement determine the basis of cooperation in strengthening and deepening the development of teaching and research.

Article 2

The signatories of this agreement will cooperate in the following areas:

- student exchanges within the master's degree program in law;
- organization of guest lectures, courses, and presentations by delegated representatives of the Faculty at all levels of study;
- realization of joint thematic workshops and round tables;
- formation of student internship programs and monitoring of student work, by the capabilities of the Faculty and the Department;
- publishing joint publications;
- organizing joint conferences, panels, and forums intended for students as well as all members of the academic and wider community;
- joint work on the promotion of legal science, project activities, and research in legal sciences;
- other forms of cooperation that the partners deem useful.

Article 3

The signatories of the Agreement agree that certain forms of cooperation provided for in Article 2 of this Agreement, if necessary, make special agreements that will precisely determine the mutual rights and obligations.

During the implementation of specific forms of cooperation under this agreement, each signatory will pay special attention to the protection of intellectual property rights, as well as the consistent application of regulations governing the field of data protection and personal data.

Article 4

The contracting parties undertake not to disclose all confidential information and documents received from each other, which relate to this contract, or are related to this contract (except for generally known data available to the public), without the prior written consent of the other party.

Article 5

This Agreement has a validity of five (5) years, may be renewed upon written consent of both parties and enters into force on the date of signature. Each party may decide to terminate this agreement, provided that the terminating party sends a written communication of termination at least six (6) months in advance.

Article 6

The agreement is approved and signed in four (4) copies, two (2) in English language and two (2) in Italian language.
