Participation and cancellation - If your application is selected you will be notified and expected to confirm the participation within 7 working days. Any other cancelation on short notice or no-show will be reported to your academic institution, occurred costs have to be borne by you. Not considered applications will be put on a waiting list. In case of cancellation of other participants, you will be notified on short notice. In addition to this you will have to submit a proof of purchased health insurance for the time of the duration of the summer school.
